- That at the Meeting there were present and/or represented 34,945,180,100 (thirty-four billion nine hundred forty-five million one hundred eighty thousand and one hundred) shares or 85.477% (eighty-five point four-seven-seven percent) of 40,882,331,500 (forty billion eight hundred eighty-two million three hundred thirty-one thousand and five hundred) shares, constituting all the shares issued by the Company to the date of the Meeting;
- That at the Meeting the appearing persons were authorized by the Meeting to restate the adopted resolutions in a deed made before a Notary and now the appearing persons wish to restate the same in this deed;
- That all matters mentioned hereinabove were set out and presented in the Minutes of Annual General Meeting of Shareholders of the Company, dated 26-04-2022 (the twenty-sixth day of April two thousand and twenty-two) number 80, passed before me, the Notary.

-Now, therefore, in connection with the foregoing, the appearing persons acting in their respective capacity as mentioned hereinabove restate herein the resolutions adopted at the Meeting as follows:

- I. 1. It is resolved to approve the amendment to the Company's articles of association with regard to the addition of a new office, namely Vice President Director, to the Company's Board of Directors in accordance with the proposed amendment to the

Company's articles of association as published on the website of the Company.

2. It is resolved to confer power and authority upon the Company's Board of Directors, with right of substitution, to restate the resolution concerning the approval of the amendment to the Company's articles of association with regard to the addition of a new office, namely Vice President Director, to the Company's Board of Directors in a Notarial Deed, to notify the Minister of Law and Human Rights of such matter, to register the same in the Register of Companies, and to take any actions as may be deemed necessary in accordance with the prevailing laws and regulations.

-Consequently, the provisions of Article 17 paragraph 1 letter a and Article 19 paragraph 7 of the Company's Articles of Association shall be amended so as to read as follows:

BOARD OF DIRECTORS

Article 17

1. a. The Company shall be managed and directed by a Board of Directors of at least 2 (two) persons, with structure as follows:
 - (1) one President Director; and
 - (2) one Vice President Director (if any); or
 - (3) one or more Directors.

MEETING OF THE BOARD OF DIRECTORS

Article 19

7. All meetings of the Board of Directors shall be chaired by the President Director or, in case the President Director is absent or hindered by any reasons whatsoever, it being unnecessary to provide proof of such impediment to any third party, the Vice President Director (if any) or, in case the Vice President Director (if any) is absent or hindered by any reasons whatsoever, it being unnecessary to provide proof of such impediment to any third party, one of the Directors attending and appointed by the meeting shall chair the meeting of the Board of Directors.
- II.
1. It is resolved to accept and approve the resignation of Mr. Priyadi from his position as a Director of the Company.
 2. It is resolved to grant full acquittal and discharge (acquit et de charge) to Mr. Priyadi for all his actions in managing the Company during his office as a Director of the Company until the closing of this Meeting.
 3. It is resolved to accept and approve the dismissal of Mr. Iwan Dewono Budi Yuwono as the President Director of the Company and the appointment of Mr. Christian Ariano Rachmat as the new President

Director of the Company and the appointment of Mr. Iwan Dewono Budiyuwono as the Vice President Director of the Company and the appointment of Mr. Wito Krisnahadi as a Director of the Company for a term of office effective as of the closing of this Meeting to 31 August 2026. The structure of the Company's board of directors shall therefore be as follows:
